

# HOLLIS HILLS JEWISH MEMBERSHIP FINANCIAL FORM

*July 1, 2011 - June 30, 2012*

In accordance with the financial policies of the HHJC it is requested that each member satisfy their obligation to pay all dues, tuition, fees, pledges and charges within time periods set by those policies. Such cooperation is needed so that HHJC can properly budget and plan for our fiscal year.

To satisfy these financial obligations to the synagogue, and entitle you to the benefits of membership including the right to member rates for the High Holidays, we ask for your election of one of the following payment options (*please initial one of the options below*):

INITIALS	PAYMENT OPTIONS
	<b><u>Lump Sum Payment of Dues - by August 31 - Credit card permitted</u></b> We ask that you agree to make a voluntary donation of 2% of each charge to help the HHJC defray the transactional costs charged by the credit companies.
	<b><u>Standard Dues Payment Plan</u></b> - At least 33% by September 1 <sup>st</sup> ; 2/3 by December 31 <sup>st</sup> . Remainder by March 31. Payments may be made by check or credit card. We ask that you agree to make a voluntary donation of 2% of each charge to help the HHJC defray the transactional costs charged by the credit companies.
	<b><u>9 Payment Plan (Credit Card)</u></b> - All financial commitments will be charged in 9 equal monthly installments from July through March (on or around the 10 <sup>th</sup> of each month) of the current fiscal year. Valid credit card information must be provided in advance (see below). We ask that you agree to make a voluntary donation of 2% of each charge to help the HHJC defray the transactional costs charged by the credit companies.
	<b><u>9 Payment Plan by Post Dated Checks</u></b>
	<b><u>Special Arrangements</u></b> - I request a meeting with the members of the Finance Committee to discuss special arrangements as my financial circumstances do not permit me to make payments through any of the above options. I will provide documentation as requested by the Finance Committee to support my request.

Please see the dues and assessments summary accompanying this form.

*Any congregant with past due balances must settle these charges prior to August 31<sup>st</sup>. All payments received will automatically be applied to past due balances and congregants will need to follow the selected option for current year obligations to receive High Holy Day tickets. Late fees will be assessed for overdue payments beyond March 31 at .5% per month.*

Failure to meet mutually agreed upon payment arrangements, may cause the synagogue to deny or suspend membership benefits including the suspension of Bar/Bat Mitzvah preparation, cancellation of Bar/Bat Mitzvah dates, barring of attendance of children in religious or pre-school. In reliance on your agreement to such payment plans and fulfillment of August 31 obligations, the HHJC will provide, for family members, High Holiday Tickets at member rates.
